WHEREAS, the recognition was granted to the institution namely St. Joseph's College of Education, Jayalakshmipuram, Mysore, Karnataka-570012 vide SRC (NCTE) order no. F.KR/B.Ed./63/SRO/NCTE/2001-02/969 dated 11.07.2000 for conducting Secondary B.Ed. course of one-year duration from the academic session 2000-2001 with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 08.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 16.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, the status of issuance of Show Cause Notice /FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22<sup>nd</sup> Oct 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. Accordingly, a Show Cause Notice was issued to the institution on 04.11.2019.
- AND WHEREAS, the SRC in 388th Meeting held on 14th & 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision a Final Show Cause was issued on 04.03.2021. The reply of the institution had already been submitted on 09.12.2019 in response to the show cause notice dt. 04.11.2019 which was placed before SRC.
- AND WHEREAS, the matter alongwith the reply of first show cause notice was placed before the SRC in its 400th meeting held on 13th - 14th July 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution St. Joseph's College of Education, Khata No. 23, Plot No. 75, Block 4, St Joseph's Complex Jayalakshmipuram, Mysore Corporation-570012 Karnataka for B.Ed. programme for 2 basic units of 50 students each."

NOW THEREFORE, this order is issued permitting the institution i.e., St. Joseph's College of Education, Khata No. 23, Plot No. 75, Block 4, St Joseph's Complex

I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

The institution shall comply with the various other norms and standards prescribed

in the NCTE Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in

- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- Available infrastructural facilities. f.
- Facilities added during the last quarter.
- Number of books in the library, journals subscribed to and additions, if any, in h. the last quarter. i.
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information if it so
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
