



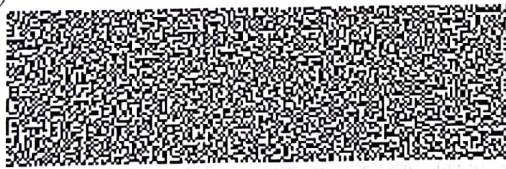

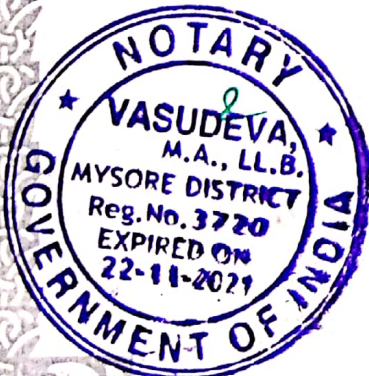

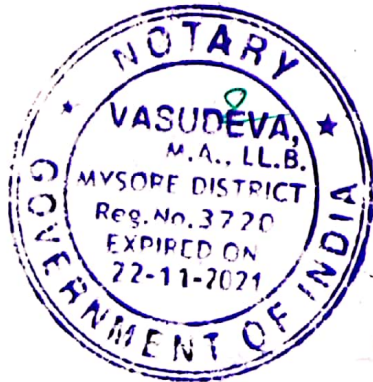
As per the application submitted by you that in the above mentioned site building construction is completed City Corporation Engineer has done the spot verification. As mentioned below action has been taken.
